Contract for Embryo Transfer

1. Royal Vista Southwest Services, Inc. (RVSW) agrees to the following:

- To transfer embryo(s) from a Donor Mare to the reproductive tract of a recipient mare of RVSW's choosing for the breeding season from Feb. 1 through Aug. 31, 2025.
- Make every reasonable effort to provide recipient mares on demand for scheduled donor mare flushes; unless conditions, catastrophic or otherwise beyond RVSW's control, make such effort impossible.
- Pay all veterinary fees associated with maintenance and preparation of recipient mares for embryo transfer up to the day of the transfer.

2. The Embryo Owner/Lessee _____ [if Lessee, provide a copy of the Lease Agreement] (Owner/Lessee will be referred to herein as "Owner") agrees to the following:

- Owner shall provide RVSW with a completed and signed 2025 Embryo Transfer Contract prior to transfer of the embryo(s).
- Pay the scheduled fees as listed:
 - \$6,000.00 ET Pregnancy Fee and Recipient Mare Lease**, which includes the fees listed below:
 - \$2,000.00 Recipient Reservation Deposit due with the signed contract, prior to embryo transfer.**
 - This contract is not valid until the \$2,000 Recipient Reservation Deposit has been received by RVSW.**
 - Contracts received without payment will not be accepted should RVSW close contracts and book full prior to receiving payment.
 - Deposits are **non-refundable, non-transferable and may not be used to pay any remaining balance on an account under any circumstances.** Deposits may be rolled over **one year** if a pregnancy is not attained in the 2025 breeding season.
 - In case multiple recipients are needed, one Recipient Reservation Deposit is required per Recipient needed.

Recipients needed _____ (x \$2,000 per recipient) = Total required with contract \$ _____

- \$4,000.00** remainder is due when a recipient is confirmed 26 days in foal.
- \$500 ICSI/Frozen Embryo Transfer Fee** – Due at transfer for each ICSI, frozen ICSI, or frozen embryo whether thawed at RVSW or other facility. This fee is in addition to and not deducted from the ET Pregnancy Fee and Recipient Deposit Lease if pregnancy is attained.
 - \$15.00/day Board** for Pregnant Recipient Mare, beginning on the day of successful transfer.
 - Should multiple embryos be recovered from a single flush and transferred, each additional Embryo Transfer pregnancy obtained under this contract will incur **\$6,000.00 ET Pregnancy Fee and Recipient Mare Lease** when recipient is confirmed 26 days in foal.
- If the embryo(s) are being shipped to RVSW**, the breeding/flushing veterinarian and/or owner must notify RVSW regarding the Donor Mare's breeding and ovulation **on the day of ovulation**. Owner/Lessee understands that **failure to report an ovulation on the day of ovulation may result in unavailability of a recipient** for a transfer. Owner agrees to pay any and all other charges incurred in shipment of embryos, including but not limited to shipping media, air freight, courier, and return container shipping.
 - Owner shall pay all outstanding charges in full prior to removal of any Donor, Recipient, or embryo from the possession of RVSW. Owner hereby grants a security interest in Donor, Recipient, all foals resulting in whole or part from services delivered pursuant to this Agreement, and embryos owned by owner to secure payment of all sums which become due under this Agreement. Owner hereby designates RVSW as Owner's attorney-in-fact with full power to transfer ownership of Donor, Recipient, frozen semen and embryos in order to enforce RVSW's rights under this Agreement. All charges are payable within thirty (30) days of the date of the invoice. Charges left unpaid after 30 days from the date incurred will accrue interest at the rate of 1.5% per month.
 - Owner agrees to pay any and all attorney's fees and expenses, including expert witness fees incurred by RVSW in attempting to collect any outstanding balances under this Agreement. Owner acknowledges and agrees that if payment is not made when due, RVSW has the right to sell the Donor, Recipient, foal(s), and embryo(s) to recover all sums due under this Agreement in addition to any other remedies RVSW may have at law or in equity.
 - Owner warrants and guarantees that as Owner/Lessee, the undersigned has full authority to enter into this contract and is the party responsible for all terms and conditions hereof, including prompt payment of all charges.
 - Owner shall deliver the Recipient to RVSW in good health, in good flesh, and open on or before November 30th of the year she is due to foal. IF THE RECIPIENT IS NOT RETURNED TO RVSW BY NOVEMBER 30, 2026, IN GOOD HEALTH, FLESH, AND AS AN OPEN MARE, OWNER SHALL PAY RVSW A FEE OF \$3,500.**
 - Owner shall not use or allow the use of the Recipient for any reproductive purposes other than that specifically performed by RVSW. **If the Recipient is returned to RVSW but it is determined that Recipient has been used in violation of this contract without the express written permission from RVSW, the owner shall pay a fee of \$3,500 to RVSW.**
 - Owner is responsible for the care of the Recipient after 26 days of pregnancy until Recipient is returned to RVSW including, but not limited to, veterinary care, board, and feed whether services provided by RVSW or other.
 - Donor Mare Owner is responsible for all Breed Registry rules and regulations. RVSW assumes no responsibility in this regard.
 - RVSW reserves the right to refuse service. This includes the right, at RVSW's sole discretion, to discontinue embryo attempts or to refuse to transfer an unsuitable embryo.
 - Donor mare Owner is responsible for parentage verification on embryo transfer foals. RVSW will exercise its best judgment in maintaining records and identification on each Donor Mare and recipient.
 - Owner grants to RVSW and its assigns, the irrevocable and unrestricted right to use and publish photographs, videos, and descriptions of Owner's Donor(s), foals, embryos, and Recipients(s), or such digital images in which they are included, for editorial, trade, advertising, and any other purpose and in any manner and medium; and to alter and composite the same without restriction and without Owner's inspection or approval. Owner hereby releases RVSW and its assigns from all claims and liability related to said images and description.

3. Royal Vista Southwest Services, Inc. makes the following provisions:

- This contract grants one (1) Live Foal Guarantee for each paid ET Pregnancy Fee **on NON-ICSI derived embryos**, pursuant to the terms of this provision. In the event that a recipient does not produce a foal that stands and nurses, the guarantee will be honored by providing a \$3,000.00 discount for one future embryo transfer, to be performed in the same or subsequent year's breeding season. All other fees described in this Agreement shall apply to the subsequent transfer. In order to qualify for the discounted ET Pregnancy Fee & Recipient Mare Lease, all the following requirements must have been satisfied:
 - Within 30 days of the loss of the foal, the Owner agrees to provide veterinary certification that a live foal (standing and nursing) was not obtained should the Recipient be removed from RVSW.
 - If the Recipient's failure to carry to term was due to an Act of God, or sub-quality management practices and/or negligence on the part of the Owner et al, this credit provision becomes null and void.
 - Failure to attend foaling voids guarantee.**
 - Request for Live Foal Guarantee Discount must be submitted to RVSW within thirty days of the loss of the foal.
 - Owner's account must be paid in full and remain in good standing.
- For ICSI derived embryos** - Should the owner decide to leave the Recipient Mare at RVSW through her 60 day pregnancy check and the Recipient is found to be not in foal during that period, RVSW agrees to **refund \$4,000.00 (\$6,000 Pregnancy Fee less the \$2,000 Recipient Reservation Deposit)**. The Recipient Mare may be picked up at that time, *however*, should Recipient leave RVSW prior to her 60 day pregnancy check and is found to be not in foal at a later date, there will be no refund of any previously paid fees.
